NOMINATION FORM

Notice regarding legal restrictions on campaigning. Federal law prohibits the use of any union or employer funds to promote the candidacy of any person in a union officer election. This prohibition applies to cash, facilities, e-mail systems, equipment, vehicles, office supplies, etc., of OFNHP and any other union, and any employer, whether or not they employ OFNHP members. Accordingly, neither OFNHP's nor any employer's email systems, messaging systems, (including voicemail), union- or employer-paid cell phone (including text messaging), or Health connect/electronic record keeping systems – nor those of any other unions or employers – may be used for campaign purposes. OFNHP members may not campaign on union – or employer-paid time and union officers and employees may not campaign on time paid for by the union.
